#### **Boat Launch Pier**

- Pier is currently falling apart and is rotting. Budget for Maintenance (720.5) is \$200. Permanent pier was discussed. Looking at bids for permanent pier or seasonal options.
  - Judy discusses concerns with a permanent pier with snowmobilers. Need reflectors possibly.
- Looking at the budget and will need a special meeting if pier costs exceed budget.

#### **Other Business**

- Before adjournment will ask if there are any other questions but these items cannot be voted on.
- Discussed when the launch will be locked for the season. Had 5 outstanding commercial summerset permits at time of meeting to be done in December. If locked, then summerset calls Chairman Willems to unlock the gate. Gate is usually locked when ice starts to form (late November). It was not locked at the time of meeting. Copies of keys to me made for three board members in case the gate needs to be opened.
