Commissioners Meeting Minutes - DRAFT July 19, 2022

Opening

The regular meeting of the Board of Commissioners of the Lake Keesus Management District was called to order at 6:30 p.m. on July 19, 2022, at Town Hall by LKMD Chairman Dan Willems.

Confirmation of Postings

Business Google Drive Storage

- Talked about meeting to go over all hard-copy documents and move to a google drive business account. Only the board will have access to this account. If someone would like information on a document or other information they may contact one of us.
- Prices range from \$6-\$18/month based on storage.
- Commissioners made plans to go through all documents before the annual meeting.

DNR permit for Weed Harvesting and Buoys

- In 2016 there was a permit application for slow no wake buoys in Marquardt's bay. It was never signed off by DNR. Last week it was signed off and we now have a DNR permit for the buoys.
- Last year at the annual meeting a vote was taken to remove slow no wake buoys and the
 motion was carried. The town of Merton has the authority to take in/out the buoys. An
 email will be sent to them to remove the buoys.
- Our weed harvesting permit expires next year. We need to have a plant survey. It was quoted at \$6,000. This needs to be done this year.

Boat Launch

- The pier needs to be replaced. Two quotes have been made. We need to get a third quote. The price will be between \$20,000 and \$30,000 for a permanent pier. There will be a motion to approve the pier at the annual meeting. It will be the same size as the current which is 6.5 feet wide and 30 feet long.
- No complaints were received on the ramp at the boat launch since the lake level was low.

Other Discussion

- We discussed NR107 and NR109. If passed, this would increase weed harvesting permit costs, resulting in higher management district tax assessments for lake house owners.
- Lake Keesus currently pays \$300 for a 5-year weed harvesting permit, but with this permit, it would increase to over \$2,000 for the same 5-year permit.
- The LKMD budget is currently being assembled by Pete.
- The annual meeting will be held on October 12, 2022.
